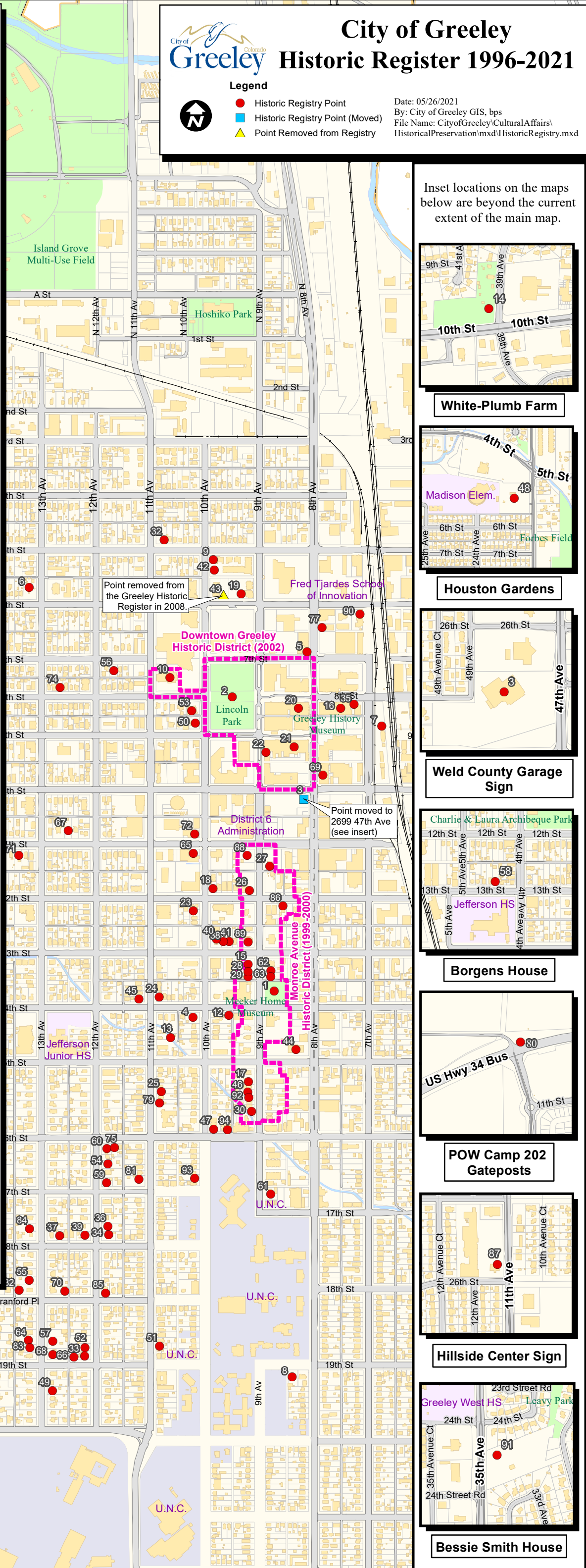

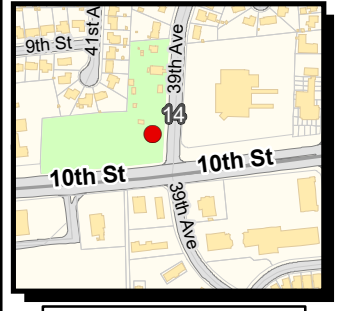

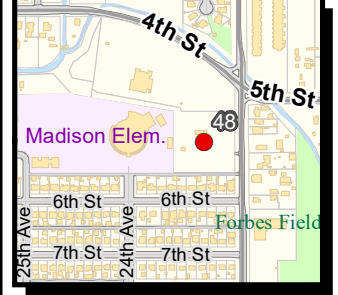

Inset locations on the maps below are beyond the current extent of the main map.



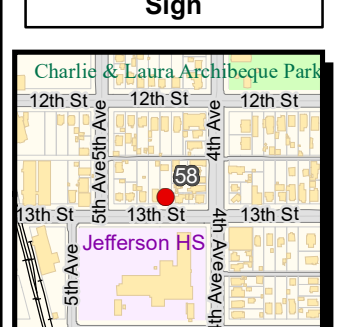

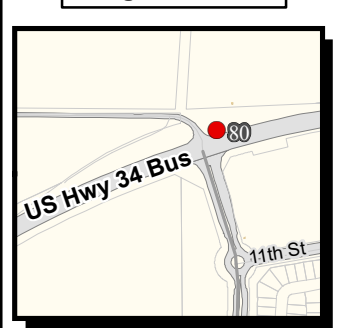

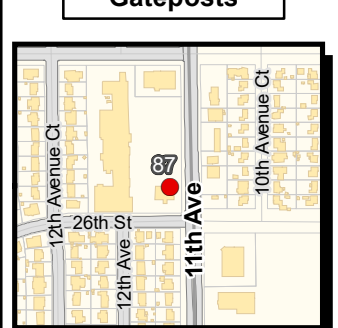

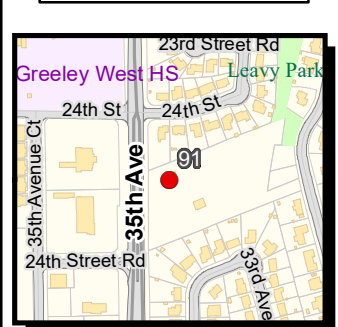
