The City of Greeley, Colorado is requesting **sealed** bids for UCCC Acoustic Panels Replacement Assessment **DUE July 27<sup>th</sup>**, **2023 before 2 PM MST** via electronic submission which at that time all bids will be publicly opened and read aloud via video conferencing. <u>No late or faxed bids will be accepted</u>. It is the responsibility of the vendor to ensure the solicitation documents are submitted to the correct email address as noted in the Solicitation Documents. Solicitations delivered to other City of Greeley email addresses may be deemed as late and not accepted.

Only email's sent to will be considered as responsive to the invitation to bid. Emails sent to other City emails may be considered as non-responsive and may not be reviewed.

Bids shall be submitted in a single Microsoft Word or PDF file under 20MB.

The Bid number and Project name **must be noted** in the subject line, otherwise the Bid may be considered as non-responsive to the Bid.

Electronic submittals will be held, un-opened, until the time and date noted in the Bid documents or posted addenda.

The City of Greeley disseminates all bids through the Rocky Mountain E-Purchasing System site. Go to http://www.RockyMountainBidSystem.com, then "Bid Opportunities" and then select "The City of Greeley". Bids submitted to the City of Greeley must include all Sections in this invitation. Addenda must be acknowledged in the bidding documents. Bidders failing to acknowledge any and all addenda may be considered non-responsive.

No bid shall be withdrawn after the opening of the bids without the consent of the City of Greeley, Colorado, for a period of sixty (60) days after the scheduled time of the receiving the bids.

All bids/proposals will be confidential until a contract is awarded and fully executed. At that time, all bids/proposals and documents pertaining to the proposals will be open for public inspection, except for the material that is proprietary or confidential. However, requests for confidentiality can be submitted to the Purchasing Contact provided that the submission is in accordance with the following procedures. This remains the sole responsibility of the offeror. The Purchasing Contact will make no attempt to cure any information that is found to be at a variance with this procedure. ## **Scope of Work**

### **Background**

The City of Greeley is a home rule municipality with a council-manager form of government and is the county seat and the most populous municipality of Weld County, Colorado. Greeley is in northern Colorado and is situated 52 miles north-northeast of the Colorado State Capitol in Denver. According to the U.S. Census Bureau, the population of the city is roughly 111,000 which makes it the 12th-most populous city in Colorado. The City has an annual budget of ~\$490M with a fiscal year that starts Jan 1<sup>st</sup>, and employees over 1100 employees. Greeley is a major city of the Front Range Urban Corridor and home to the University of Northern Colorado which is a public baccalaureate and graduate research university with approximately 12,000 students and six colleges as well as Aims Community College, which has served the community since 1967.

The Union Colony Civic Center is Northern Colorado's premier performing arts venue, owned and operated by the City of Greeley. Built in 1988 with a combination of public funds and private donations, the UCCC is home to two performance venues, Monfort Concert Hall, seating 1,686 and Hensel Phelps Theatre, seating 214. The UCCC programs a wide variety of Broadway musicals, concerts, comedy shows, dance, and other performances. The UCCC runs on a semester schedule; Spring (January through April) and Fall (September through December), which each include approximately 10 performances.

#### **Overview**

The City of Greeley is looking for bids for assessment services for the replacement of the existing Variable Acoustical Panel system with a new Variable Acoustical Panel System at the Union Colony Civic Center. This assessment will involve an acoustical analysis to anticipate the uses of the Monfort Concert Hall. An acoustical engineer for the panels and include but not limited to structural and an electrical engineer to complete a detailed design and analysis for the end goal of a full design ready to include stamped plans for construction as well as documentation or certified plans on the removal or securement of the existing variable acoustical panels. All plans and documentation to be shared both as hard copies and .pdf and .dwg digital formats. Availability of any walk-through on the build project as well as any RFI's in the building process and any necessary information to obtain permits from the building department.

Electrical power feeds to existing acoustic motorized panels should be adequate for reuse to new replacement acoustic motorized panels based on the replacement panels having the same electrical load as the existing panels. This will need to be verified when the replacement solution is determined.

#### **Goals**

The City's goals for this project are to provide the most accurate picture of the capital needs to adequately maintain the entertainment venue. The City desires to continue providing a facility that meets the needs of patrons, performers, and supporting staff as the entertainment industry continues to evolve. Each project needs to have a defined scope, timeline, accurate budget and be located in the correct order of execution.

#### Scope of Services

This solicitation is for the assessment for the replacement of the failed variable acoustics systems with new modern variable acoustics systems. Replacement would include both replacement of the side wall and the attic variable acoustic systems. Replacement would eliminate concerns of failing support structures noted by staff and provide lost functionality to the room to change the acoustics to fit the performance. Example: a dead room for modern concert and a live room for orchestral or choral performance. Special care should be given to introducing a significant variable acoustic element capable of reducing the low frequency reverberation to provide impact and improved bass response to amplified music.

With further investigation, a cost saving option could be to provide fixed acoustical elements at the side walls and variability in the attic of the room only. Further cost savings can be realized if the acoustic elements are replaced with non-variable acoustical systems with an optimized neutral acoustical setting. This would be a compromise for all uses and would not provide ideal acoustics for either amplified music or orchestral or choral music.

The Awarded Bidder will manage the acoustical analysis, recommendations, and coordination of the improved acoustics systems. The Awarded Bidder will also design and document recommendations for the replacement / reconfiguration of the acoustical panels in the Monfort Performance Hall. A full acoustical analysis and recommendations are necessary. This includes coordinating the desired acoustical performance relative to anticipated uses, performing a specific acoustical analysis, documenting the changes and additions for bidding the improvements, and construction installation verification. The Awarded Bidder will also provide documentation/plans for the demolishment or securing of the existing non-functional acoustic system.

#### The Awarded Bidder will also be responsible for the following items:

The Awarded Bidder will meet with the city of Greeley culture representatives to gather information about the current conditions. Design meetings will be held as required to achieve progress. They will provide a complete set of stamped construction drawings and specifications. These documents and specifications will be used as guiding documents for Phase 2 scheduled for 2024.

Construction drawings shall contain all information necessary to obtain a permit through the city of Greeley Building Department.

The Awarded Bidder will verify any new design and / or equipment meets the needs and functions of the building as well as all current building codes.

In addition to design drawings and engineering services, The Awarded Bidder will provide construction observation services. This will include reviewing and answering questions during the city's bidding process for construction and during the construction which Is scheduled for 2024, answering any questions from the building department during the permitting process, redesigning and clarifying to the building official if changes are required, writing addenda to the project plans and specifications, reviewing submittals for adherence to Construction Documents and providing RFI responses. During construction observation we will attend regular meetings, at dates to be determined by the city.

The Awarded Bidder will provide general floor plans to support the work included and these will be based on documents provided by the city of Greeley. Where necessary, we will field verify existing elements to ensure accuracy, but it is not in the Architect's scope for this project to provide detailed, field verified as-built drawings of the entire facility.

The City does not anticipate any Mechanical or Plumbing engineering requirements. If these services are required, with the Owner's approval, they will be an additional cost.

Fire alarm and fire protection system design / reconfiguration by others – the fire department expects Design-Build subcontractor submittals.

#### **Period of Award**

The completion date of providing the required product and services shall be for the **term of an estimated 100 days** with a completion date of November 31, 2023. Work will begin after, and only after, a fully executed contract with The Awarded Bidder and the City of Greeley has been signed.

If the City desires to extend the contract, no later than thirty (30) days prior to expiration, the City's Purchasing Contact may send a notice in writing to the vendor requesting firm pricing for the next twelve-month period. After the City evaluates the firm pricing proposal from the vendor, it will determine whether to extend the contract. All awards and extensions are subject to annual appropriation of funds. The provisions of the foregoing paragraphs with respect to extensions of the terms of the contract shall be null and void if the contract has been terminated or revoked during the initial term or any extension thereof. All decisions to extend the contract are at the option of the City.
